Right on Woodward to Broadway, turn right.

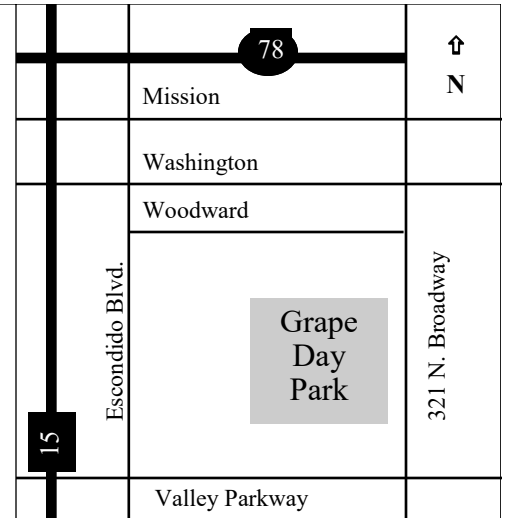
From Coastal North County, Orange County & LA
